

This competition, **Three One4All Voucher Survey Competition 2025 (the “Competition”)**, is organised by Three Ireland (Hutchison) Limited (“Three”)  
Competition Dates: 30<sup>th</sup> April 2025 – 15<sup>th</sup> June 2025

1. You must be aged 16 and over and be a resident of the Republic of Ireland to enter this Competition.
2. The Competition commences on 30<sup>th</sup> April 2025 and ends on 15<sup>th</sup> June 2025.
